Report of the SLA Annual Conference

The Annual Conference in New York was a huge success with an attendance of over 6,000. The days were filled with interesting programs, panel discussions, tours and general sessions. The Biological Sciences Division had a number of interesting sessions that were well attended. On Monday, June 12, the Division co-sponsored a program on biology subject cataloging with the Technical Services Group of the Information Technology Division. The speaker was Cortez Austin from the Library of Congress. That afternoon, the Division organized a field trip to the American Museum of Natural History. It began with lunch in the Audubon Gallery and was followed by a slide show of the rare books collection and a talk by Dr. Robert Carneiro on the new South American Peoples exhibit.

On Tuesday, June 13, the Executive Board met to close activities for 1988-1989 and to prepare for the Division Business meeting which was that afternoon. During the morning, we co-sponsored a BIOSIS Update with the Pharmaceutical Division. BIOSIS announced the availability of CAS registry numbers for searching BIOSIS Previews on STN and the expansion of Bio-Business to cover more literature particularly in the areas of food science and technology and cosmetics.

Wednesday, June 14, we co-sponsored a program on acid rain with the Environment & Resource Management Division. The three speakers were quite good and the moderator, Fred Stoss of the Environment & Resource Management Division gave a good overview of the topic as well as an introduction for the speakers. On all four evenings from Sunday until Wednesday, the Division cosponsored a hospitality suite with the Environment & Resource Management Division. This was a great

success with many members attending and meeting one another again or for the first time. We feted our speakers on these evenings as well as celebrated the merger of two divisions to form the Environment & Resource Management Division.

On Thursday, the Division organized field trips to Central Park and to Memorial Sloan-Kettering Cancer Center. The rain in the morning did not dampen the spirits of the hikers and talks were very informative. The afternoon tour to Memorial Sloan-Kettering was quite fascinating. It included a tour of the new research facilities and the MRI lab.

During the meeting, planning continued for Division events at the 1990 Annual Meeting in Pittsburgh. Once again, we will co-sponsor our hospitality suite with the Environment & Resource Management Division. We will be joined by two other divisions, Chemistry and Pharmaceutical. All of those divisions will be co-sponsoring programs with us. So far, the topics include food and biotechnology, molecular databases and biosequencing, the farreaching effects of environmental accidents and perhaps bioethics. I will keep you informed of the planning as we move through the year.

I have had an interesting year as Chair-Elect and have learned very much from working with Eleanor, Jean and the Executive Board. I look forward to working with our new board members, Barbara Montanary and Jane Cole as well as continuing to work with Jean. Thank you for your interest in working with Division committees. Student Stipend Award Essay

Janice, who has a Ph.D. in zoology, will complete her M.L.S. in August at the Graduate School of Library and Information Science, University of Illinois.

The prime directive of libraries is to provide access to information. Wilson reminds us that "the bibliographic universe is not under effective control until anyone can discover those of its inhabitants that will suit his or her purposes, whatever those purposes may be" (emphasis added). A variety of problems impact on the ability of the biology librarian to fulfill this mission.

The dynamic nature of biological sciences is one contributing factor. The merger of chemistry and biology is apparent at all levels of biological organization. Similar hybridization is occurring between biology and physics. The emergence of biotechnology has introduced new overlaps between biology and business, government, and ethics. This is a small sampling of the ways in which biological thought is engaging other disciplines. To what extent should the biology library support interdisciplinary interests by providing physical access to major tools and works in these other disciplines? This is a major collection development issue in small biology libraries. In large, decentralized academic libraries, such tools may already be available elsewhere in the system. In these libraries it is important to define collection development responsibilities in interdisciplinary areas not clearly within the acquisitions policy of any departmental library. In either case, given financial constraints, expansion of the collection into new areas of research may threaten the development of the collection in more traditional areas. With the advent of networking among libraries, cooperative collection building and enhanced document delivery may alleviate some of the pressures to provide physical access to an ever-expanding literature.

Providing subject access to these new areas of biological thought also presents problems. Existing controlled vocabulary may be inadequate, creating difficulty in both cataloging and retrieval. Failure of discipline-based classification schemes to gather related interdisciplinary works in one location further inhibits retrieval. Scattering of interdisciplinary works through several class numbers makes shelf browsing difficult at best. As the potential power of online catalogs becomes reality, subject access may be improved by greater depth of indexing, assignment of multiple class numbers, or other mechanisms for

embodying the content of works. Whether technical services functions will be adequately supported to realize this potential remains to be seen.

Bibliographic access in biology has been greatly affected by the development of online databases. These have become major tools for the identification of documents. The number of online databases has burgeoned in recent years. New databases provide access in new interdisciplinary areas such as biology and business. As users of biology libraries become interested in questions involving other disciplines such as law and ethics, there is increased demand for biology librarians to search in databases that serve these disciplines. Searching each efficiently requires practice and familiarity with the database. This is just one way in which responding to the changing needs of users has required broader skill and expertise of the biology librarian.

Both biology and librarianship are being driven by rapid technological change. Undoubtedly many new issues concerning access will arise. As biology librarians evaluate potential impacts of technological innovations, it is imperative that we maintain a clear vision of our prime directive.

New Business


Motion passed to support travel for the Chair and Chair-Elect to attend the Winter and Annual Conferences.


