

### Letters to the Editor

I have read the 1993 student stipend award winning essay, and I am rather concerned about its message. The parts pertaining to librarianship in general are fine, but the claim that "biotechnology needs to be taken out of the realm of the risky...", and the position that all fears on the part of the public are unjustified are simply ill-informed, biased promotion. If the writer had qualified her remarks by limiting them to those librarians employed by biotechnology companies, where promotion is the purpose of the information dispensed (and, thus, where the practice of censorship/disinformation is necessary), they would not be so inappropriate. However, information centers concerned with providing complete, unbiased information about biotechnology do exist, and for librarians working in them, Ms. Meil's suggestions are unacceptable.

I am an MLS candidate with a B.S. in Biology who has been working in the Biotechnology Information Center at the USDA's National Agricultural Library for quite some time. I have made every effort to provide our patrons with balanced information, since our center is part of a publically funded library. It is not our place to be advocating biotechnology, but merely to gather and disseminate all available information pertaining to agricultural biotechnology. Contrary to Ms. Meil's blanket statement that all scientists are confident of the the safety of biotechnology, there are significant numbers of scientists voicing concerns and acknowledging that risks do indeed exist and need to be considered, not ignored in the name of profits. I am acquainted with Ms. Meil, as she was employed part time until recently in the Plant Genome Information Center here at NAL. If she had consulted those of us in the BIC who are familiar with the variety of literature, organizations, and information sources covering biotechnology, perhaps she could have produced a piece based on the "complete information" she mistakenly cites as necessary to allaying fears about biotech. I can only wonder why she did not do so. Her list of sources was extremely limited, and not even current.

I would very much like to know the source of funding for the student stipend. I feel that this should have been published along with the essay, as such information can be very revealing.

The Past Chair of the Career Development/Public Relations Committee replies:

The Career Development/Public Relations Committee each year solicits essays from student members of SLA to to provide a stipend to attend the annual conference. The funding is provided by the Biological Sciences Division. At present there is no outside funding solicited or given.


Last year, the announcement for the essay competition appeared in the Winter issue of *Biofeedback*. One of the requirements stated that "Persons wishing to apply must ... submit an essay of 1,000 to 1,200 words discussing a problem, issue, or challenge facing biological sciences librarianship... Essays will be judged on the basis of good argument development and critical analysis, clear language, conciseness, and creativity."

By definition, an essay is "a literary composition usually dealing with a subject from a limited or personal point of view." The committee examined each essay submitted with that in mind, and judged them on the criteria stated above. It did not expect a submission to compete at the level of a research paper, nor to be heavily referenced. In my experience over several years, essays with references are the exception, rather than the rule.

I believe that the key here is that the essay, unlike a research paper, is meant to identify a topic, formulate an argument for a particular view, and defend that argument. Ms. Meil chose a topic that certainly has many differing viewpoints, as Ms. Wiggert has pointed out. But nowhere in her essay did I find that she had made a "blanket statement that all scientists are confident of the safety of biotechnology." In the context of her argument, I, at least, interpreted her essay to be about librarians working with biotechnologists, and that they presumably would have, in Ms. Meil's words, "become comfortable with biotechnology and offer confident estimates of safety."

I certainly appreciate Ms. Wiggert's concerns about the nature of the essay and the competition. By discussing controversial topics within the biological sciences, all librarians can become more confident in the quality of information provided to a variety of interest groups.
