Ms. Rowland called the meeting to order. She welcomed the members and introduced and thanked our financial contributors. Sixty-six members signed the attendance roster. The SLA Board Proctor was Ms. Julia Peterson.

Treasurer's Report-

The secretary/treasurer, Nancy Kozlowski, reported that she filed the Mid-Year Financial Report of the Division with SLA HQ. A Call-for-Budgets went out to all program planners, officers, committee chairs on May 31, 1996. Budget requests for the coming year should be sent to the new treasurer, Ms. Janet Chisman, by the end of June. The Operating Fund showed a balance of \$10,319.78 at the end of May 1996, and the reserve fund showed a balance of \$3803.54 at the end of December 1995. The \$6,250 raised this year by Dr. Larry Kelland and the Fund Development Committee was extremely important to preserving the reserve fund and meeting our current anticipated expenses for the annual conference and the bulletin.

Nominations & Elections-

Fred Roper was elected chair-elect.

Janet Chisman was elected Secretary/Treasurer.

Archives-

Dottie Riemenschneider asked people to send materials to her at the University of Michigan Library. Landmark members of 30, 35, 40, 45, and 50 years were announced by Ms. Rowland -- Ms. Rowland noted that one of our 50 year members, Ms. Winifred Sewell, is in attendance today.

Bulletin-

Ms. Rowland announced that Adam Schiff, editor of the Division's bulletin for the past five years, is leaving the position. She thanked him for getting a good bulletin out on time for five years. Mr. John Tebo will be the new bulletin editor. Mr. Tebo asked for a volunteer to serve as assistant editor.

By-Laws-Patricia Yocum

Ms. Youum distributed the proposed changes to the members in attendance and reviewed the changes for the members. Today's report is for information only. The proposed changes, already approved by the BSD Executive Board, will be published on BSD-NET. These proposed changes go to the Association's By-Laws Committee for approval. By next spring these proposed changes will go to the BSD membership for a vote for approval.

Ms. Yocum reported on the Biological Sciences Division's recent efforts with SLA regarding the formation of a Health Sciences Division. These efforts center on two matters. First, the lack of a scope note on any of the 27 petitions stating the purpose of the new division is a problem. Second, the motions, made by two guests rather than two members, at the 1996 Winter Cabinet meeting, to create the new division is a problem. The BIO Executive Board has asked the SLA Board of Directors for a review of the validity of each matter. BYLAWS CHANGES

As noted in the last issue of <u>Biofeedback</u> Division Bylaws are being reviewed in two phases. The first set of proposed changes appears below. These changes have been approved by the BIO Executive Board (June 1996) and by the SLA Bylaws Committee (August 1996). The next step is to submit them to the BIO membership for a vote at the Annual Business Meeting, June 1997 in Seattle. They are offered here for your information and to encourage discussion.

If you have questions please contact Patricia Yocum, Chair of the 1995-96 Bylaws Committee (which drafted the attached changes), Lucy Rowland, Chair, David Duggar, Virginia Lingle, or Adam Schiff, members, 1996-97 BIO Bylaws Committee.

SLA BIOLOGICAL SCIENCES DIVISION Proposed Changes to Division Bylaws July 1996 Revised November 1996

Additions are noted in **bold type**. Deletions are noted in brackets [].

1. Article III. Executive Board. Section 2.

The Board shall consists of [five] six members elected by the membership: the chair, the chair-elect, the [immediate] past chair, the [secretary-treasurer] secretary, the treasurer, and one director.

2. Section 3.

[Three] Four members of the Board shall constitute a quorum

3. Section 5.

The term of office of the secretary shall be one year. The term of office of the [secretary-treasurer] treasurer and the director shall be two years.

4. Article IV. Officers. Section 1.

The chair . .with the [secretary-treasurer] the treasurer, shall sign all contracts and other legal documents;

5. Section 3.

The [secretary-treasurer, as secretary,] secretary shall keep [,] a record of all meetings of the Division and of the Executive Board; [with the chair, shall sign all contracts and other legal documents;] and shall perform other duties as the chair may assign.

6. Section 4.

The [secretary-treasurer, as treasurer,] treasurer shall have custody of the Division funds; shall sign all checks drawn upon Division funds unless determined otherwise by the Executive Board; with the chair, shall sign all contracts and other legal documents; and shall furnish such financial statements as may be required by the Executive Board, the chair, and the Association Division Cabinet Officers.

7. Section 6

The director shall be a member of the Executive Board; shall act as parliamentarian for the Division; shall keep the Division Procedures Manual up-to-date; and shall carry out such duties and special projects as the chair may assign.

8. Article VII. Sections. Section 1

Sections relating to definite areas of interest within a Division may be established by the Executive Board upon written petition of [thirty] fifteen members of the Division who desire to participate in the activities of the proposed Section.

9. Article VIII. Funds, Contracts, and Property. Section 4.

Officer, members of the Board or committee chairs who shall be incurring expenses connected with official programs of the Division shall obtain prior authorization for the expenditure from the chair or the [secretary-treasurer] treasurer. Officers, Board members, and committee chairs shall be reimbursed by the [secretary-treasurer] treasurer for authorized expenses upon presentation of itemized receipts.

10. Article IX. Nominations. Section 2.

Each year, the Nominations and Elections Committee shall present at least two candidates for chair-elect [,] and secretary, and in alternate years, for [secretary-treasurer] treasurer and director, each of whom will serve for two years.

11. Section 3.

The report of the Nominations and Elections Committee shall be published in the official bulletin or otherwise sent to Division members at least [ninety] 150 days before the Division annual business meeting. Further nominations, . . . may be entered by petition of twenty Division members, and shall be filed with the Nominations and Elections Committee at least [sixty] 120 days before the annual business meeting.

12. Section 4.

Election shall be by printed ballot [mailed] distributed to each Division member at least [forty-five] ninety days before the Division annual business meeting. Completed ballots must be postmarked not later than sixty days prior to the same meeting.

GOVERNMENT RELATIONS UPDATE

Susan C. Curtis Government Relations Liaison

NTIS has confirmed that it will cease the print product Government Reports Announcements and Index by December 1996. The 1995 and 1996 annual indexes of GRA/I will not be published. Current plans for the replacement CD-ROM product called "Order Now" do not include depository distribution. NTIS is preparing to work with the University of California-Davis Library on a pilot project to provide depositories with online access to electronic images of federally funded scientific, technical and engineering publications in the NTIS collections. Libraries would be expected not to use the database for commercial purposes. According to the Agency's 1995 annual report, which was released this past summer, NTIS net earnings dropped due to the poor performance of its Clearinghouse Program.

The Department of Energy's Office of Scientific and Technical Information no longer has sufficient funding to support its microfiche program. Distribution of DOE reports and publications on microfiche (class E 1.99: nos.:) ceased on September 30th, 1996. The Library Programs Service division of the Government Printing Office has a test tape containing sample image files of DOE reports. Investigations are underway to determine how best to distribute the reports electronically.

The Fall meeting of the Depository Library Council was held on October 20th-24th in Salt Lake City. The National Commission on Libraries and Information Science Focus Group on Assessment of Standards for Creation and Dissemination of Electronic Government Information met to discuss the direction of electronic distribution of federal information. In the future GPO Access will utilize OpenText retrieval software to provide links between related data products, bookmarking, an online tutorial and better search capabilities. GPO hopes to work with the National Archives and Records Service to produce guidelines regarding permanent access to federal documents issued in electronic format in the coming year. It was reported that users are downloading an average of 2.5 million documents per month from over 70 databases on GPO Access. The distribution of tangible products for FY96 (some 29,400 titles) was down from FY 95 (44,700 titles).

The Government Printing Office's Access service now provides selected sections of the Code of Federal Regulations including those parts dealing with the Food and Drug Administration (Title 21) and the Environmental Protection Agency (Title 40). To go directly to the CFR on the WWW enter: http://www.access.gpo.gov/nara/cfr. Each title is revised annually. When a revision is printed, an online edition will also become available so soon the entire set should be available at the Web site.

Sandy Morton-Schwalb, SLA's former Government Relations Director, is now a member of the Government Printing Office's Electronic Transition Staff. She will assist the Library Programs Service with the move to an electronically based Federal Depository Library Program. Her office will be working with PURL (Persistent Uniform Resource Locators) software for use among Federal publishers. PURLs allow servers to map a request to a new URL when a server moves. It is hoped that use of PURL software will eliminate the need for the GPO to change URLs in Monthly Catalog records.

Canadian depositories are rejoicing that now they now may search Canadian documents which are listed in the pink checklists from January 1995 to the present on the Web. The Weekly Checklist Catalogue is the Depository Services Program's searchable catalog of Parliamentary, departmental and statistical publications. The search engine permits searching by title, author, subject, language, Checklist number and ISBN or ISSN. INTERNATIONAL RELATIONS COMMITTEE SURVEY



Liese Tajiri and Tom Turner will serve as moderators for the annual contributed papers session entitled, "From Reactive to Proactive: Substantive Approaches for Incorporating the Internet into Biological, Medical, and Life Sciences Libraries."
