

## **AWARDS COMMITTEE UPDATE**

## **Division Members Honored**

Later this year, three members of the Biomedical and Life Sciences Division will be honored for their accomplishments:

**Lorri A. Zipperer** (Cybrarian, Zipperer Project Management, Evanston, Illinois) will be presented with the 2003 SLA H.W. Wilson Company Award at the SLA Annual Conference. This award is given for the best article published during the previous calendar year in *Information Outlook*. Lorri (who also won the award in 1994) will receive it for "Communicating Competencies and Collaboration" [*Information Outlook* 6(9): 28-34], which she co-authored with fellow SLA member Sara R. Tompson.

Naomi C. Broering (Director, W. C. Herrick Community Health Care Library, La Mesa, California) will be presented with the Marcia C. Noves Award at MLA '03, the 2003 annual meeting of the Medical Library Association (MLA). The Noves Award is the highest professional distinction awarded by MLA, recognizing a career that has resulted in lasting, outstanding contributions to health sciences librarianship. Naomi served as President of MLA, Editor of the Journal of the Medical Library Association (formerly the Bulletin of the Medical Library Association), and Chairman of the MLA Legislation Committee. She also served on the MLA Board of Directors. She is a Distinguished member of the Academy of Health Information Professionals and a Fellow of the American Medical Informatics Association. She has served as the Executive Director of the Houston Academy of Medicine-Texas Medical Center Library, as Director of the National Network of Libraries of Medicine, South Central Region, and as Director of the Georgetown University Medical Center Library. Naomi received the SLA Professional Award in 1987 for her expertise in library automation and her contributions to special librarianship. She is the first recipient of the Division's Winifred Sewell Prize, awarded in 1999 for her leadership in developing, applying, and promoting new technologies in libraries. Currently, she edits the electronic newsletters of the Friends of the National Library of Medicine and the Friends of the National Institute of Dental and Craniofacial Research.

**J. Michael Homan** (Director of Libraries, Mayo Clinic and Mayo Foundation, Rochester, Minnesota) will be designated as an MLA Fellow at MLA '03. This honor is conferred in recognition of his outstanding and sustained contributions to the advancement of the purposes of MLA. Michael has served as President of MLA, on its Board of Directors, and chaired numerous committees, topical sections, and task forces within the organization. He also served as editor of the *Bulletin of the Medical Library Association*, and as MLA's first managing editor of books.

## **Book Review Section**

## David V. Alford

A Color Atlas of Pests of Ornamental Trees, Shrubs and Flowers

448 pages, \$59.95 (cloth)

Portland, Oregon: Timber Press, 2003.

This is an identification book and the focus is on "recognizing the various pests associated with ornamental plants in the British Isles and much of continental Europe from the Alps northwards. Biological details, and information on the importance of such pests and how to control them, are also given. Many of the pests included here also occur in other parts of the world, including North America, Japan and Australasia." Identification is an essential starting point in controlling pests.

The majority of the book is devoted to insects and mites. An example would be the vine weevil, *Otiorhynchus sulcatus*. There is a color photograph of the adult on a rose blossom along with photographs of the eggs, larva and pupa. The text covers the plants affected, description of the pest, life history, damage and control. Often a photograph shows the effect of the insect on a leaf or plant, e.g., a wilted *Fraxinus* shoot, web nests in cherry trees, galls on various plants, or the mine of an elm leaf-mining weevil. Miscellaneous pests are broadly covered in 11 pages.

I asked a botanist and the head of our university's greenhouse to look at this book and both thought it was a very useful book for the identification of the pest. The photographs are high quality. The control part is rather general in terms of specific insecticides but non-chemical methods are covered and the author states "are often preferable and frequently just as effective." There is a selected bibliography, an index of host plants, and a general index. In conclusion, I would highly recommend this book for academic and public libraries. It should be useful to the professional and the layperson who need to control pests on plants in greenhouses and outdoors.
